Organizations are eligible to apply once per 12-month period. The Foundation will only consider requests from qualified tax-exempt, nonprofit 501(c)3 organizations that support the following programs as a charitable entity:

- Educational programs, such as student development, youth camps, or tutoring
- Health and Human Service programs, such as those addressing poverty, hunger, illnesses, special needs, illiteracy, or veterans' needs.
- Historical, or Cultural, programs, such as Black History month, Juneteenth and August Quarterly.

Organizations requesting funding for the first time are limited to a \$500 request and must provide a report of how the funds were used within 6 months of receiving grant funds.
